First order of business, David McDaniel made a motion to approve the agenda, 2nd by Terry Wilson, all in favor, none opposed, motion carried.

Approval of the minutes, Edward Dunn made a motion to approve the minutes, 2nd by David McDaniel, all in favor, none opposed, motion carried.

No old business

New business: Chairman Anglea read rules of order and opened the public portion of the meeting.

Item 1. Re/Classification of property from SR to HC and AG to HC, owned by Stephen Richards in land lot 261 district 9 of Murray County, being 33 acres, addressed on Spring Place Smyrna Road. Dick Barnes said the request was in order for hearing and he does recommend approval. The property has been used as a family farm. Nancy Young said all notices had been sent. No one present for or against the request. Public portion of the hearing closed for board discussion. David McDaniel made a motion to approve the request, 2nd by Edward Dunn, all in favor, none opposed, motion carried.

Item 2. Re/Classification of Property owned by Linda Green from SR to AG in land lot 12 district 9 of Murray County being 10 acres and addressed on Red Cut Road. Dick Barnes said the request is in order for granting and is being used as pasture land, he recommends approval. Nancy Young said all notices have been sent to adjacent property owners. Gary Spivey was present to represent Ms. Green. No one present for or against the request. Public portion of the hearing closed for board discussion. Edward Dunn made a motion to approve the request, 2nd by Terry Wilson, all in favor, none opposed, motion carried.

Item 3. Re/Classification of property from SR to RR owned by Serephia Choate in land lot 55 district 9 of Murray County being 2.66 acres addressed as 29 Floodtown Road Spur. Ms. Choate would like to put a mobile home on the property. Dick Barnes said the motion was in order for granting and he recommends approval as there are mobile homes in this area. Nancy Young said all notices have been sent to adjacent property owners. No one present for or against the request. Public portion of the hearing closed for board discussion. Motion made by David McDaniel to approve the request, 2nd by Edward Dunn, all in favor, none opposed, motion carried.

Item 4. Conditional Use of Property owned by Maurice and Karen Coulter addressed on Old Federal Rd. South, being 92.34 acres. The Coulters would like a conditional use to be allowed to house animals for

adoption. Dick Barnes said the request was in order for granting and he recommends approval. He said in any zone district the conditional use for an animal shelter has to be obtained. No one present for or against the request. Public portion of the meeting closed for board discussion. Terry Wilson made a motion to approve the request, 2nd by David McDaniel, all in favor, none opposed, motion carried.

Item 5. Re/Classification of Property from SR to MHP, owned by Teresa Holcomb in land lot 50 district 8 of Murray County, being 26.24 acres on Will Evans Road. Mr. Barnes said the request was in order for granting and he does recommend approval. He said the property has mobile homes on it now and Ms. Holcomb would like to put another mobile home there on an empty lot. The property has always been used as a mobile home park, and is now non-conforming. Nancy Young said all notices have been sent to adjacent property owners. Carol Macon said she does not approve and thinks it will make the value of her property go down. Mr. Barnes said the zone district does not affect the value of the adjoining properties. No one else for or against the request, public portion of meeting closed for board discussion. Edward Dunn made a motion to approve the request, 2nd by Terry Wilson, all in favor, none opposed, motion carried.

Item 6. Re/Classification of property from HC to SR, owned by Nolan Burnett at 439 Cliffmine Road in land lot 320 district 26 of Murray County being 1.54 acres. Dick Barnes said the use of the building is now residential and no longer used as commercial. Ms. Dianne Hughes, mother of Nolan Burnett, was present. Nancy Young said all notices have been sent to adjacent property owners. No one present for or against the proposal. Public portion of meeting closed or board discussion. David McDaniel made a motion to approve the request, 2nd by Edward Dunn, all in favor, none opposed motion carried.

Next order of business: Members Edward Dunn and David McDaniel appointed for 4 more years on the commission board. Both agreed to another term.

No other business motion made by Edward Dunn to adjourn the meeting, 2nd by David McDaniel, meeting adjourned.

B. Resolution: One Georgia Authority Equity Application for Agriculture Center Project \$225,000

**MURRAY COUNTY RESOLUTION
FY 2014 OneGeorgia Authority Equity Application
Agricultural Center Project**

WHEREAS, the OneGeorgia Authority has established the Equity Fund Financial Assistance program to assist cities and counties with promoting health, welfare, safety, and economic security of the citizens of the state through the development and retention of employment opportunities in areas of greater need as defined by the Georgia Business Expansion and Support Act of 1994, as amended (O.C.G.A. 48-7-40).

WHEREAS, there exists in Murray County a need to improve employment opportunities and to promote the health, welfare, safety, and economic security of its citizens by providing an Agricultural Center to enhance regional competitiveness and workforce development,

NOW THEREFORE, BE IT RESOLVED by the Sole Commissioner that the County will apply for OneGeorgia Authority Equity funds in the amount of \$255,000.00 to complete construction of an Agricultural Center in Murray County, Georgia. The County commits \$12,000 to fund the cost of all grant writing and grant administration costs associated with the project. The County understands that the Murray County Board of Education commits to provide funding for all other costs associated with the project over the OneGeorgia grant award amount;

BE IT FURTHER RESOLVED that Murray County understands that the Murray County Board of Education will retain ownership of the project, and the County will enter into an intergovernmental agreement with the Murray County Board of Education for the ownership, operation, and maintenance of the Agricultural Center upon completion of the project;

BE IT FURTHER RESOLVED that the Sole Commissioner is authorized and directed to act as the official representative of the County to act in connection with the application and to be responsible for compliance with the applicable State and Federal requirements of the program and to provide such additional information as may be required;

BE IT FURTHER RESOLVED that the Sole Commissioner is authorized to enter into an agreement for grant administration services relating to the subsequent grant (if funded) and to execute any required documents relating to said grant application, if required;

BE IT FURTHER RESOLVED that this project is in compliance with the County's Comprehensive Plan and Short Term Work Program and is not inconsistent with the County's Service Delivery Strategy;

BE IT FURTHER RESOLVED that a true and dedicated commitment has been made by the County to the project for its successful completion.

Fireworks Display Contract

THIS CONTRACT (this "Contract") is made this _____ day of _____, 2014 by and between Pyrotecnico, a Pennsylvania Corporation ("Pyrotecnico"), and Murray County Commission ("Sponsor"), with its principal place of business located in Chatsworth, Georgia

WHEREAS, Pyrotecnico is desirous of providing Sponsor with a fireworks exhibition and display for Sponsor's benefit under such terms and conditions as provided herein, and thereby, the parties agree as follows:

1. Fireworks Display.

Pyrotecnico shall sell, furnish and deliver to Sponsor certain fireworks which Pyrotecnico agrees to exhibit and display on

DATE: July 5, 2014 / **Rain Date:** July 6, 2014 (Please fill in Rain Date)

(Note: Rain dates not available on July 2-4, 2014 – If planning a Rain Date during July 4th week, please consult with your Show Producer before submitting) in accordance with the program set forth and agreed upon at the time of the signing of this Contract, the specifics of which are set forth in the "Fireworks Exhibition and Display Program" attached hereto and incorporated herein by reference thereto (the "Fireworks Display").

2. Payment Schedule.

For and in consideration of the Fireworks Display, Sponsor agrees to pay Pyrotecnico the contract price of \$ 10,130.00* *Includes \$30 permit fee (the "Contract Price") paid as follows: a. 50% of the Contract Price due upon the signing of this Contract; b. the balance of the Contract Price due within ten (10) days of completion of Fireworks Display.

Sponsor agrees to pay interest at the rate of 1½ % per month on any delinquent balance of the Contract Price until paid in full. Payment shall be made by certified check or otherwise as agreed by Pyrotecnico to Pyrotecnico at P.O. Box 149, New Castle, PA 16103. Furthermore, in the event Sponsor fails to perform its obligations and responsibilities as set forth herein and it becomes necessary for Pyrotecnico to enforce its rights by hiring an attorney or third party, Sponsor shall be responsible for all fees and costs incurred by Pyrotecnico to collect said sums.

3. Display Responsibilities.

Pyrotecnico and Sponsor will collaborate in the performance of all tasks relating to the Fireworks Display. These tasks include, but are not limited to, (i) procuring and furnishing a place suitable for the Fireworks Display (the "Display Site"), (ii) applying for, obtaining and securing all permits, licenses and approvals required by all applicable local, state and federal laws and regulations as well as those required by any local police and fire departments for the Fireworks Display (collectively, the "Required Approvals") Sponsor is responsible for the payment of all governmental fees and expenses imposed or applied to this exhibition including any fees or expenses incurred after the signing and execution of contract for said show, (iii) providing adequate private and/or public security, police and fire protection, (iv) securing an acceptable location with private and/or public security personnel to park the Pyrotecnico fireworks truck(s) overnight (or for such longer or shorter period as Pyrotecnico may reasonably require in order to effectively provide the Fireworks Display), (v) securing adequate protection to preclude all individuals, other than those authorized by Pyrotecnico, from entering the security area designated by Pyrotecnico, (vi) removing and keeping unauthorized persons, as well as, personal or real property of any kind, including, without limitation, motor vehicles, outside of the area designated by Pyrotecnico as the Display Site, fallout area or safe zone. Pyrotecnico and Sponsor shall fulfill their responsibilities as set forth herein in accordance with all local, state and federal rules, laws, orders and regulations, including those of the National Fire Protection Association (NFPA).

4. Crediting.

Sponsor agrees to credit Pyrotecnico as "Fireworks by Pyrotecnico" in all advertising/marketing materials that are within the Sponsors authority.

5. Indemnification and Limitation of Liability.

Sponsor shall indemnify, defend and hold Pyrotecnico and its shareholders, directors, officers, employees, agents, representatives and insurers harmless from any and all demands, claims, causes of action, judgments or liability (including, without limitation, the costs of suit and reasonable costs of experts and attorneys) arising from damage to or destruction of property (including, without limitation, real and personal) or bodily or personal injuries (including, without limitation, death), whether arising from tort, contract or otherwise, that occur directly or indirectly from (a) the gross negligence or willful misconduct of Sponsor or its employees, agents, contractors or representatives, or (b) the failure of Sponsor to comply with its obligations and responsibilities as set forth herein. Whereas, Mr. Howard has an extensive list of local history involvement including: volunteering at the Chief Vann House since 1978, organized Friends of the Vann House in 1989, led the effort to survey all of Murray County's cemeteries, chaired the Murray County History Committee that researched, wrote and published Murray County Heritage in 1987 along with several other publications, taught Murray on my Mind 1986-2011, appointed as first and only Official Murray County Historian in 2008, four successful National Register nominations for Murray County historic districts, served on committees to restore and preserve the old Spring place Methodist church, the Wright Hotel, the Chatsworth Depot and the Murray County High School's Rock Building, served 2 terms as the president of the Whitfield-Murray Historical Society and involved with numerous other projects, committees and boards; and

WHEREAS, Mr. Howard has received numerous honors including: Murray County Teacher of the Year twice, STAR Teacher twice, American History Teacher of the Year by the Georgia Daughters of the American Revolution & the Georgia Colonial Dames, Berry College Alumni Assoc. President's Award twice and a Distinguished Service Award, Sponsor of the Year for Georgia State Jr. Beta Club Council, Chamber of Commerce Young Man and Humanitarian of the Year and Community Champion of the Year; and




