
Certification of Road Abandonment Of
A Section of Shelton Road


WHEREAS, it has been determined by the governing authority of Murray County that a certain undeveloped section of Shelton Road, has ceased to be used by the general public to the extent that no substantial public purpose is served by it and this section of said road has become a nuisance to the community; and

THEREFORE, after notice to the property owners located thereon and after notice of such determination is published in the newspaper, in which the sheriff's advertisements for the County are published, once a week for a period of two weeks and after a public hearing on such issue; and

THEREFORE BE IT RESOLVED, pursuant to O.C.G.A. 32-7-2(b)(1) the governing authority of Murray county does hereby declare that a section of Shelton Road, consisting of .28 miles of right of way and as depicted on the attached map, is abandoned and that section of road shall no longer be part of the County road system and the rights of the public in and to the section of road as a public road shall cease.

G. Ordinance: Roadway Solicitation – 1st Reading

Murray County, Georgia Ordinance

Solicitation for contributions within the rights-of-way of roads and highways.

(a)

Charitable organizations registered in accordance with O.C.G.A. § 43-17-5 and such other organizations exempt from registration in accordance with O.C.G.A. § 43-17-9 are authorized to solicit charitable contributions upon the roads and highways within the unincorporated portion of Murray County, Georgia, subject to compliance with the requirements of this section.

(b)

Charitable organizations seeking a permit pursuant to this section shall file an application, upon a form to be provided by Murray County Commissioner's Office. Such application shall include the name, address, and telephone number of the organization, the officers of the organization, documentary proof of registration of the organization in accordance with O.C.G.A. § 43-17-5 or proof of exemption from such registration in accordance with O.C.G.A. § 43-17-9, the date(s), time(s), place(s), and names and ages of participants of the proposed solicitation and shall include an agreement by the organization to hold harmless and to indemnify Murray County from any and all liability for injury or damage arising out of the permitted solicitation. The organization shall provide proof of general liability insurance coverage with aggregate limits of not less than \$1,000,000.00 insuring against any loss which may arise as a result of the proposed solicitation. A permit fee of \$10.00 per event day shall be paid upon submission of the application.

(c)

All individuals requesting permission to solicit contributions on behalf of an organization applying for a permit hereunder shall be not less than 21 years of age.

(d)

All individuals authorized to solicit contributions on behalf of organizations pursuant to this section shall wear reflective safety vests or other similar reflective safety apparel at all times.

(e)

The hours during which charitable organizations holding permits pursuant to this section may solicit contributions shall be not earlier than 8:00 a.m. and not later than 6:00 p.m., Monday through Saturday.

(f)

Permits shall be nontransferable and shall expire not more than 30 days after issuance.

(g)

Organizations shall maintain a copy of the permit available for inspection during the course of any solicitation.

(h)

Either the sheriff, his duly authorized representative, or the county commissioner may revoke any permit issued to any organization upon receipt of a credible report of the use of vulgar, insulting, offensive, or threatening language during the course of any solicitation or upon reasonable cause to believe that such solicitation is causing a potential traffic hazard, danger to motorist(s), danger to any individual involved in the solicitation, or that any other federal, state, or local law, rule, or regulation has been violated during the course of any solicitation.

(i)

Pursuant to the provisions of O.C.G.A. § 36-1-20(b), the maximum punishment for the violation of this section shall not exceed a fine of \$1,000.00 or imprisonment for 60 days, or both.


Murray County Government Disposal of Surplus Inventory


