



### Minutes

Murray County Land Use Planning Commission Meeting  
April 18, 2017

The meeting was called to order at 7 pm by Chairman Steve Anglea. Other members present were Terry Wilson, Edward Dunn, David Wells, Dick Barnes, Land Use Administrator for Murray County and Jazmin Flores, Planning Commission Secretary.

The first order of business on the agenda was approval of the agenda. David McDaniel made the motion to approve the agenda. Terry Wilson seconded the motion and the motion carried.

The second order of business was approval of the minutes of the March 21, 2017 meeting. Edward Dunn made the motion to approve the minutes as written. David Wells seconded the motion. The motion carried with a unanimous vote.

Having no old business, the Chairman opened the first item of new business which was Conditional Use for farm animals. Located 506 Haygood Rd, Land Lot 235 and District 13 of Murray County consisting of 2 acres and identified as Tax Parcel 0008-075, owned by Thomas & Holly Nathe.

Mr. Barnes stated area is mix use with agricultural zone across the road. Existing structures on property are ok to be used and if any new structures are added a variance will be needed. Mr. Barnes also stated the request was in order for granting and recommends approval. Mrs. Flores stated that all proper public notices had been made. Thomas & Holly Nathe were present and addressed the counsel. Holly stated they are wanting to use the frame from existing barn as the shelter and would only have 6 goats. There was no one else there in favor or against the proposal.

The Chairman closed the public portion of the meeting for board discussion. David Wells made a question on how they planned to prevent from having more than 6 goats. Thomas Nathe stated he plans to sell the goats, and will have two nannies bred and will only keep it at 6. He also stated he will sell the goats before he allows the nannies to breed again. Thomas also said he plans to fence three quarters of the property for the goats. Edward Dunn made the motion to approve the request with a limit of 6 goats anything over would result in a violation. David McDaniel seconded the motion and the motion carried in favor of the request.

Having no other business, David McDaniel made the motion to adjourn. Edward Dunn seconded the motion. The motion carried and the meeting adjourned at 7:12 P.M.
