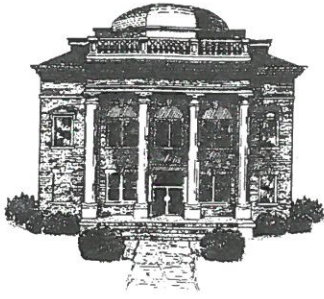

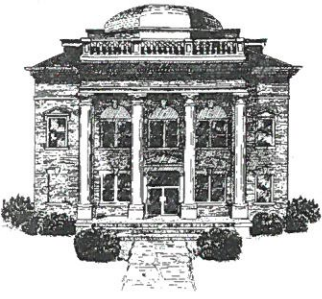

Minutes

Murray County Land Use Commission Meeting

May 16, 2017

The meeting was called to order at 7 pm by Chairman Steve Anglea. Other members present were Edward Dunn, Terry Wilson and Dick Barnes, Land Use Administrator for Murray County.

The first order of business on the agenda was approval of the agenda. Chairman Steve Anglea dropped item 3 from the agenda. Terry Wilson made the motion to approve the agenda as presented with the deletion of item 3. The second was made by Edward Dunn. The motion carried.

The second order of business was approval of the minutes of the April 18, 2017 meeting. Edward Dunn made the motion to approve the minutes as written. Terry Wilson seconded the motion. The motion carried with a unanimous vote.

The Chairman opened the public hearing on item 1 of the agenda which was the Re-Classification of property from Suburban Residential to Manufactured Home Park. Located at 9023 Hwy 225 N., Land Lot 242 and District 10 of Murray County. Consisting of 3.97 acres and identified as Tax Parcel 0043 - 019, owned by James Buchanan.

Mr. Barnes stated that all proper public notices had been made and the property was in order for granting. He also stated that the property is an existing Manufactured Home Park, with approved additional spaces available. Mr. Barnes stated that in his opinion that this would be a correction of the present Land Use map and recommends approval. Mr. Buchanan was present but did not wish to address the board. No one else was there in favor or against the request. The chairman closed the public portion of the meeting for board discussion. Edward Dunn made the motion to approve the request. Terry Wilson seconded the motion and the motion carried in favor of the request.

The Chairman opened the public hearing on item 2 of new business, which was the Re-Classification of property from Suburban Residential to Agriculture, Located on Plemons Rd., Land Lot 267 and District 10 of Murray County. Consisting of 13.51 acres and identified as Tax Parcel 0061 - 004, owned by Amanda E. Saylor.

Mr. Barnes stated that all proper public notices had been made and the property was in order for granting. He also stated that the area is a mix of residential and agricultural uses and that Ms. Saylor's property was adjoined by AG parcels and met the minimum size for Agriculture classification. Mr. Barnes also recommended approval. Ms. Saylor was present but chose not to comment on the request. No one else was there in favor or against the request. The chairman closed the public portion of the hearing for board discussion. Terry Wilson made the motion to approve the request. Edward Dunn seconded the motion. The motion carried in favor of the request.


The Chairman opened the public hearing on item 4 of new business, which was the Re-Classification of property from Agriculture to Suburban Residential, Located at 660 Sitton Rd., Land Lot 264 and District 9 of Murray County. Consisting of 2.0 acres and identified as Tax Parcel 0049C - 231, owned by Teresa Diane Garland.

Mr. Barnes stated that all proper public notices had been made and the property was in order for granting. He also stated that the property is part of an estate and that there is a brick home located on the 2 acres that Ms. Garland wants to have reclassified. Agriculture classification requires a 5 acre minimum and that is the reason for the 2 acre request. Mr. Barnes recommended approval. Ms. Garland was present but chose not to comment on the request. No one else was there in favor or against the request. The chairman closed the public portion of the hearing for board discussion. Edward Dunn made the motion to approve the request. Terry Wilson seconded the motion. The motion carried in favor of the request.

The Chairman opened the public hearing on item 5 of new business, which was the Re-Classification of property from Suburban Residential to Rural Residential, Located at 63 Viola Dr., Land Lot 18 and District 8 of Murray County. Consisting of 1.97 acres and identified as Tax Parcel 0069 - 227, owned by Amanda Winkler.

Mr. Barnes stated that all proper public notices had been made and the property was in order for granting. He also stated that the area is a mix of residential uses and that Ms. Winkler's property was adjoined on 2 sides by Rural Residential property and recommends approval. Ms. Winkler was present but chose not to comment on the request. No one else was there in favor or against the request. The chairman closed the public portion of the hearing for board discussion. Terry Wilson made the motion to approve the request. Edward Dunn seconded the motion. The motion carried in favor of the request.

Having no other business, a motion to adjourn was made by Edward Dunn and seconded by Terry Wilson. The motion carried and the meeting adjourned at 7:15 p.m.

RESOLUTION
AUTHORITY TO BORROW OPERATING FUNDS

WHEREAS, under and by virtue of Article IX, Section V, Paragraph 5 of the Constitution of Georgia of 1983, each city, county and political subdivision of the State authorized to levy taxes is given the authority to make temporary loans between January 1, and December 31, in each year upon certain conditions; and

WHEREAS, such conditions have been fulfilled by the county as hereinafter appears; and

WHEREAS, Murray County has now, no such outstanding temporary loans or renewals thereof made in any prior years; and

WHEREAS, under the aforesaid authority, the county may make temporary loans against a line of credit to be established at an amount not to exceed \$3,000,000, which does not exceed seventy-five percent of the total gross income from taxes in the last preceding calendar year; and

WHEREAS, Murray County, Georgia has established a budget for the operation of Murray County which will result in needful and necessary expenditures in the total sum of \$16,811,971 which shall require expenditures in advance of the collection of annual ad valorem taxes in 2017, and will result in casual deficiencies of operating funds, and it is necessary that the County make a temporary loan to pay the current year's operating expenses; and

WHEREAS, the Commissioner of Murray County constitutes the governing body of said County;

NOW THEREFORE, BE IT RESOLVED, that Commissioner Greg Hogan, or County Manager Tommy Parker are hereby authorized to borrow money on such terms and conditions as deemed best and necessary in order to meet operating expenses incurred by Murray County for the remainder of calendar year 2017.


BE IT FURTHER RESOLVED that, said loans shall be re-paid and the line of credit closed on or before December 31, 2017.
