1. The 2017 Annual Report was completed and submitted 2-13-18
2. The Stormwater Management Plan (SWMP) was completed and submitted 5-24-18
3. We have completed the outfall screenings for this year.
4. We submitted a Watershed Protection Plan Annual Report, completed a fish study and completed the required sampling.
5. Set up Goggle drives with all new documentation so that everyone involved has access.
6. We had the annual employee training on 11-9-18
7. The only EPD approval we currently have is the 2015 Annual Report. We are still waiting to hear about the 2016 AR, 2017 AR and the 2018 SWMP
8. Eton was added to our program
9. The website was updated to include Eton and the most up-to-date info
10. All we have left to map and inspect in the county is the area northwest of Eton which includes: Brookhaven subdivision, Keener Rd, Weaver Dr. and Glenn Howard Rd.
11. We did 3 plan reviews in 2018 including: MC Fire Dept, on Hwy. 225, MCHS Stadium Modifications and Reed Mini Warehouses on Luffman Rd.

## **INTERGOVERNMENTAL AGREEMENT**

This Intergovernmental Agreement ("Agreement") is made and entered into, by and between Murray County (County) and the City of Chatsworth Water Works Commission (Commission).

### **WITNESSETH**

The County and Commission are mutually desirous to enter into an Agreement that would extend sanitary sewer infrastructure to the industrial park located on Smyrna Church Road. Whereas the County was the recipient of a \$600,000 Appalachian Regional Commission Grant (Grant) and whereby the county has committed to provide \$200,000 in funds to said project, the Commission agrees to provide additional funding, engineering, construction and inspection services as outlined below.

### **COMMISSION**

- (1) The Commission will provide engineering service for said project including all environmental and historical documents required for the Grant, project design and layout, flow and pump calculations and any necessary bid documents.
- (2) The commission will be responsible for bidding, procuring and approving all materials and services for said project.
- (3) The commission will act as the contractor for the County on said project including hiring any sub-contractors as needed that meet the requirements as outlined in the Grant.
- (4) The Commission's engineer or assigned inspector will inspect all aspects of the project.
- (5) The Commission agrees to provide additional funding of up to \$600,000 for said project.
- (6) Invoices will be sent to the County by the 10<sup>th</sup> of each month for the previous months work with payment due by the 10<sup>th</sup> of the following month. Invoices will include engineering, permitting and easement acquisition cost, labor and materials on a per foot basis for all linear portions of the project and hourly rates or bid prices with materials for non-linear portions of the project.

### **COUNTY**

- (7) The county will be responsible for submitting and maintaining all Grant related documents including all draw request.
- (8) The County will be responsible for any auditing cost associated with the Grant.
- (9) The County agrees all infrastructure will be owned and maintained by the Commission and any expansion or taps will be the sole discretion of the Commission.
