**BUILDING INSPECTION/LAND DEVELOPMENT OFFICE  
MURRAY COUNTY, GA  
FEE SCHEDULE**

A permit is required for any structure 120 sq. ft. or more. Fees cover all construction related inspections and are calculated on the total square footage to be constructed. **An Application Fee of \$25.00 applies to all permits, unless otherwise noted. A re-inspection Fee of \$75 will apply after the first re-inspection. All fees are to be paid prior to any permitting, inspection or evaluation of activities by this office.**

**Residential Construction (House)**

\$250 for the 1000 square feet, plus \$.20 per square foot over 1,000

**Addition to existing Residential structure (attached)**

Heated space	\$.20 per square foot (\$50 Minimum)
Garage/Basement/Storage	\$.08 per square (\$50 Minimum)

**Manufactured Homes**

Single Wide	\$200
Double Wide	\$250
Triple Wide	\$275

**Electrical Re-Connect or New Service**

Storm Damage	N/C (No Application Fee)
100 amps or less	\$50
200 amps	\$75
300 amps	\$85
400 amps	\$95
500 amps	\$100
600 amps	\$105
Over 600 amps	\$105 plus \$.15 per amp over 600 amps

**Storage Building, Barn**

Storage Buildings	\$50 plus \$.08 per sq. ft.
