Minutes

Murray County Commissioner's Meeting

May 3, 2022

The Sole Commissioner of Murray County, Greg Hogan, called the meeting to order at 9:00A.M., May 3, 2022 in the Hearing Courtroom of the Murray County Annex. In attendance were Greg Hogan, Sole Commissioner, Tommy Parker, County Manager, Dick Barnes, Billy Childers, Edward Dunn, Jack Reed, Jimmy Espy, Mike & Sharon Brusnahan, and Tina Choate, Commissioner's Office personnel.

The first order of business was to approve the Minutes of the last meeting. The Commissioner reviewed and **Approved** the Minutes as written for the April 4, 2022 meeting.

The next order of business was to approve the agenda for today's meeting. The Commissioner asked if anyone had anything to add to or delete from today's agenda. There were no additions or deletions requested. The agenda was **Approved** by the Commissioner.

New business was next on the agenda. Under new business the following items were discussed:

Item A of new business was the Review/Approval of the Murray County Land Use and Development Planning Commission Minutes from April 19, 2022. Murray County residents, Mike & Sharon Brusnahan of 144 Reservoir Road, were present at the meeting. Their property is at/near the property seeking approval to develop a RV campground. Mr. Brusnahan states he had several concerns about the development of a campground. Mr. Brusnahan referred to a list of concerns the Commissioner had previously been given. The list included issues regarding soil/sewer, traffic, camp site size, buffer (tree line) between adjoining property, on site staff for the campground, and policies set in place for a RV campground. Each issue had been addressed at the Land Use Planning Commission Meeting. Commissioner Hogan assured the Brusnahan's that guidelines are in place for each of his concerns and will be strictly enforced by Murray County Code Enforcement, and local law enforcement. Commissioner Hogan then **Approved** the actions of the Land Use Planning Commission as outlined in the Minutes of the April 19, 2022 meeting.

Item B of new business was the 1st Reading of the Amendment to the Code of Murray County, Chapter 18, Article II, Water and Sewer Construction Codes. The 2nd Reading for the Amendment was scheduled for May 17, 2022 at 9:00A.M. in the Hearing Courtroom of the Murray County Annex.

Item C of new business was the 1st Reading of the Amendment to the Code of Murray County, Chapter 26, Article III, Light Nuisance. The 2nd Reading for the Amendment was scheduled for May 17, 2022 at 9:00A.M. in the Hearing Courtroom of the Murray County Annex.



Item D of new business was the approval of the Agreement for the Fireworks display scheduled for July 2, 2022 – rain date July 9, 2022 – by Pyrotecnico Fireworks, Inc. The cost of the fireworks display is \$13,350. The Agreement was Approved by Commissioner Hogan.

Item E of new business was a Resolution for the Campaign signs at Hyden-Tyler Recreation Center. Commissioner Hogan Approved the Resolution. The Resolution is in the Auxiliary Files.

Commissioner Hogan adjourned the meeting.
