## Minutes

### Murray County Commissioner's Meeting

June 7, 2022

The Sole Commissioner of Murray County, Greg Hogan, called the meeting to order at 9:00A.M., June 7, 2022 in the Hearing Courtroom of the Murray County Annex. In attendance were Greg Hogan, Sole Commissioner, Tommy Parker, County Manager, Edward Dunn, Tina Spuduck (981 Jackson Lake Rd), Richard Harkins (967 Jackson Lake Rd), Farrell Keener (905 Jackson Lake Rd), Jimmy Espy, Jimmy Davenport, and Tina Choate, Commissioner's Office personnel.

The first order of business was to approve the Minutes for prior meetings. The Commissioner reviewed and **Approved** the Minutes as written for the May 3, May 17, and May 19, 2022 meetings.

The next order of business was to approve the agenda for today's meeting. The Commissioner asked if anyone had anything to add to or delete from today's agenda. There were no additions or deletions requested. The agenda was **Approved** by the Commissioner.

New business was next on the agenda. Under new business the following items were discussed:

Item A of new business was the Review/Approval of the Murray County Land Use and Development Planning Commission Minutes from May 17, 2022. Commissioner Hogan **Approved** the actions of the Land Use Planning Commission as outlined in the Minutes for the May 17, 2022 meeting.

Item B of new business was Resolution No. 062022: Certification of Road Abandonment of Jackson Circle. Pursuant to O.C.G.A. 32-7-2(B)(1) the Sole Commissioner of Murray County, Georgia, Greg Hogan, **Approved** the abandonment of Jackson Circle, consisting of .048 miles of undeveloped right of way. That section of road will no longer be part of the County Road System. The rights of the public in and to the section of road as a public road shall cease.

Item C of new business was the Resolution to adopt the Amended and Restated 401(a) Defined Contribution Plan. Supporting documents can be found in Minutes Book #11 and are also outlined in Item D. **Approved**

Item D of new business was the Adoption of the Amended and Restated 401(a) Defined Contribution Plan. **Approved and Adopted**
