### Minutes

#### **Murray County Commissioner's Meeting** **JULY 2022 Meeting held on June 28, 2022**

The Sole Commissioner of Murray County, Greg Hogan, called the July 2022 meeting to order at 9:00A.M., June 28, 2022 in the Hearing Courtroom of the Murray County Annex. In attendance were Greg Hogan, Sole Commissioner, Tommy Parker, County Manager, Jimmy Espy, and Tina Choate, Commissioner's Office personnel.

The first order of business was to approve the Minutes of prior meetings. The Commissioner reviewed and **Approved** the Minutes as written for the June 7, 2022 Commissioner's Meeting, the June 7, 2022 1<sup>st</sup> L.O.S.T. renegotiations public called meeting, and the June 14, 2022 2<sup>nd</sup> L.O.S.T. renegotiations public called meeting. Murray County Land Use & Development Planning Commission did not meet in June. There were no Minutes for June from the Murray County Land Use & Development Planning Committee.

The next order of business was to approve the agenda for today's meeting. The Commissioner asked if anyone had anything to add to or delete from today's agenda. There were no additions or deletions requested. The agenda was **Approved** by the Commissioner.

New business was next on the agenda. Under new business the following items were discussed:

**Item A:** The Sole Commissioner, Greg Hogan, reviewed and **signed** The L.O.S.T. Distribution Certificate prepared by Tommy Parker, Murray County Manager & Chief Financial Officer. Mr. Parker created the Certificate after The Mayor for the City of Chatsworth (K.W. Gong), the Mayor for the City of Eton (Billy Cantrell), and the County of Murray agreed on the terms at the June 14, 2022 meeting. Prior to today's Commissioner's meeting the City of Chatsworth held a City Council Meeting on June 20, 2022. During that meeting the Mayor for the City of Chatsworth, K.W. Gong, presented the Certificate to the City Council (Chatsworth) and Mr. Gong signed the Certificate. After signing the Certificate today, The Commissioner asked Mr. Parker to take the Certificate to Billy Cantrell, the Mayor for the City of Eton. Mr. Cantrell will present & sign the Certificate at the City of Eton Council Meeting that will be held on July 5, 2022.

**Item B:** The Commissioner **approved and re-appointed** Junior England & Heath Harrison to the Murray Recreation Board for a new 4-year term.






**Item D:** Mr. Hogan **approved** the Disposal of Surplus Inventory which includes red metal roofing & horse stall bars.
