(Monday through Saturday 7:00 am until 12:00 (midnight) and Sunday from 12:30 pm until 11:30 pm. 2nd Reading scheduled for February 7, 2023 at 9:00 am in the hearing room of the Annex Building.*
 - F. *Amendment: 1st Reading to Amend Chapter 38 of The Code of Murray County to prohibit temporary or permanent placement of recreational vehicle(s) (RV's), camper(s), or tent (as defined by Murray County Manufactured Housing Regulations) on any parcel or tract of land for the purpose of occupancy within unincorporated areas of Murray County. 2nd Reading scheduled for February 7, 2023 at 9:00 am in the hearing room of the Annex Building.*
 - G. *Amendment: 1st Reading to Amend Appendix A & B of The Murray County Code regarding lot sizing and permitted uses.*
 - H. *Amendment: 1st Reading to Amend Chapter 54 of the Murray County Code to allow different types of materials & culverts, approved by Public Works, to be used for Driveway Drainage Pipes.*
