Minutes Murray County Commissioner's Meeting October 4, 2022

The Sole Commissioner of Murray County, Greg Hogan, called the meeting to order at 9:00A.M., October 4, 2022 in the Hearing Room of the Murray County Annex. In attendance were Greg Hogan, Sole Commissioner, Tommy Parker, County Manager, Jimmy Espy, Kallie Payne, and Tina Choate, Commissioner's Office personnel.

The first order of business was to approve the agenda for today's meeting. The Commissioner acknowledged and addressed the addition of "Item F" on today's agenda was added after the public notice was sent to the media and published for the public. After the public acknowledgement, the Commissioner **approved** the agenda.

The next order of business was to approve the Minutes of the meetings held in September 2022. The Commissioner reviewed and **approved** the Minutes as written for the September 6, 2022 & September 8, 2022 meeting(s).

New business was next on the agenda. Under new business the following items were discussed:

Item A: The Sole Commissioner, Greg Hogan, reviewed and **approved** the Minutes as written for the Murray County Land Use and Development Planning Commission Meeting held on September 20, 2022.

Item B: Keep Murray Beautiful applied for a GA EPD Recycling, Waste Reduction & Division, Grant. The grant, if approved, would provide \$49,000 toward the purchase of one, F-550 to be used for roll-off container transport. The county would be responsible for an in-kind contribution. The Commissioner has **approved** the transfer of a roll-off bed from an inoperable truck owned by the county to the new F-550.

Item D: The Commissioner of Murray County, at the request of the District Attorney, Bert Poston and Superior Court Judge, Scott Minter, **approved** an agreement requesting to use the meeting room of Murray County Board of Education located at 1006 Green Road, Chatsworth, GA 30705. The Commissioner believes the use of the B.O.E meeting room is in the best interest of the citizens of Murray County to accommodate a disabled resident of the County to be able to attend the trial set to begin October 11, 2022.

Item E: Greg Hogan, Murray County Sole Commissioner, held the (first reading) to amend the Special Acts, Article IV, part-time Magistrate combined days. The amendment is necessary to update Murray County's Code to reflect the change made by GA Legislation.

Item F: Commissioner Hogan **Approved** the grant application for the VOCA/CESF-Victims of Crime Act to continue the position of (Victim Advocate) through the D. A's Office for FY2023. The grant would provide \$61,773 for Victim Advocate(s) salary

The Sole Commissioner of Murray County **Adjourned** the meeting.
