Minutes

Murray County Commissioner's Meeting February 3, 2023

The Sole Commissioner of Murray County, Greg Hogan, called the meeting to order at 9:00 a.m., February 3, 2023, in the Hearing Room of the Murray County Annex. In attendance were Greg Hogan, Sole Commissioner, Tommy Parker, County Manager, Edward Dunn, Dick Barnes, and Tina Choate, County Clerk.

The first order of business was to approve the agenda for today's meeting. The Commissioner, Greg Hogan, asked if anyone had any additional items to add to the agenda or if there are any requests to delete items from today's agenda. There were no addition or deletion requests. The Commissioner approved the agenda as written for February 3, 2023.

The next order of business was to approve the minutes for two previous meetings in the month of January (2023). The January 3, 2023, Commissioner's Meeting, and the January 3, 2023, Public Meeting to finalize the FY 2023 Budget. The Commissioner reviewed and **approved** the Minutes as written for January 3, 2023, Murray County Commissioner's Meeting, and the January 3, 2023, Public Hearing.

New business was next on the agenda. Under new business the following items were discussed:

Item A: The Sole Commissioner, Greg Hogan, conducted the **2nd Reading** to *Amend Chapter 6* of The Code of Murray County. Chapter 6 of The Code of Murray County Defines Alcohol type(s) & Pouring Outlet(s), Enforcement authority, Sale on Sunday(s)/Holiday(s)/Election Day(s), License requirements & Fees, Premises distance guidelines, Tax reporting & Payment requirements for retailer, wholesale dealer, distributor, manufacturers, etc., Prohibited sales and deliveries, and Revocation of license(s). The Amendment is ordained and Effective this 3rd day of February 2023.

Item B: Commissioner Hogan held the **2nd Reading** to *Amend Chapter 38* to prohibit temporary or permanent placement of recreational vehicles (RV's), camper(s), or tent(s); defined by Murray County Manufactured Housing Regulations, on any parcel or tract of land for the purpose of occupancy within unincorporated areas of Murray County. The Amendment is ordained and Effective this 3rd day of February 2023.

Item C: Greg Hogan, Sole Commissioner, presented the **2nd Reading** to *Amend Appendix A&B* of The Murray County Code to allow developer(s) to develop smaller lot(s) when access to public sewer system is accessible. If the lot(s) has access to public sewer system, then the developer does not have to account for the installation of a septic system when developing a lot(s). The Amendment is ordained and Effective this 3rd day of February 2023.



Item D: Commissioner Hogan put forward the **2nd Reading** to *Amend Chapter 54* of The Code of Murray County to allow different types of materials & culverts, approved by the Director of Murray County Public Works, to be used for driveway drainage pipes. The Amendment is ordained and Effective this 3rd day of February 2023.

Item E: The Sole Commissioner, Greg Hogan, resolved and formally adopted the updated Hazard Mitigation Plan this 3rd day of February 2023.

Item F: Commissioner Hogan, Re-Appointed Naomi Fehrle to the Murray County Board of Health. Ms. Fehrle's term is effective the 1st day of January 2023, and will expire December 31, 2028. This Re-Appointment shall be entered into the Official Minutes of the Murray County Commissioner's Office this 3rd day of February 2023.

Item G: The Commissioner, presented the details of the LMIG grant the Director of Public Works, Matt Sanford applied for to offset county paving expenses. The Project information is as follows:


