Minutes

Murray County Commissioner's Meeting

November 1, 2022

The Sole Commissioner of Murray County, Greg Hogan, called the meeting to order at 9:00A.M., November 1, 2022 in the Hearing Room of the Murray County Annex. In attendance were Greg Hogan, Sole Commissioner, Tommy Parker, County Manager, Dick Barnes, Edward Dunn, Gretchen Lughart, Tina Choate, County Clerk.

The first order of business was to approve the agenda for today's meeting. The Commissioner announced to the public that Item G, Item H, and Item I on today's agenda were added after the notice for today's meeting was posted for the public and sent to the media. The Commissioner asked if anyone had any additional items to add to or delete from today's agenda. There were no additions or deletions requested. The Commissioner approved the agenda.

The next order of business was to approve the minutes for the October 4, 2022 Commissioner's Meeting. The Commissioner reviewed and **approved** the Minutes as written for the October 4, 2022 meeting.

New business was next on the agenda. Under new business the following items were discussed:

Item A: The Sole Commissioner, Greg Hogan, reviewed and **approved** the actions of the Planning Commission as written in the Minutes of the Murray County Land Use and Development Planning Commission Meeting held on October 18, 2022.

Item B: Capital Purchase: The Commissioner **approved** the capital purchase for a 2022 Ford Super Duty vehicle for the District Attorney's Office Investigator. The amount of \$24,444.72 was paid from the ARPA Fund which will result in \$0 (zero) cost to Murray County taxpayers. The remaining balance of \$24,444.72 was paid from the District Attorney's Office Forfeiture Funds.

Item C: Greg Hogan, Sole Commissioner, approved and signed the Georgia Notice of Intent (NOI): General NPDES Permit No. GA610000 for Phase II Municipal Separate Storm Sewer Systems (MS4) as required by the State of Georgia. The current permit will expire December 2022. This is the new permit for 2023. **approved** and entered into the official Minutes of Murray County Government November 1, 2022.

Item D: The partnership agreement between Murray County, Georgia and Chatsworth Water Works Commission for the Storm Water Management Plan is **approved** and signed today, November 1, 2022, by the Sole Commissioner of Murray County, Greg Hogan. Richard "Dick" Barnes will take the MEMORANDUM OF AGREEMENT (MOA) to Chatsworth Water Works Commission to be signed by their officials. The agreement shall commence upon the signing of the document and shall terminate on the expiration date of the SWMP on December 5, 2027. Both parties (Murray County and Chatsworth Water Works Commission) may terminate the MOA with a 30-day written notice.



informing the other party of their intentions to terminate the agreement. Signed by the Commissioner of Murray County and entered into the official Minutes of Murray County Government November 1, 2022.

Item E: Richard "Dick" Barnes publicly presented to the Commissioner the Annual Stormwater Government Officials Updates: Murray County, Chatsworth, and City of Eton. The Commissioner **approved** the updates as presented by Mr. Barnes. A detailed document can be found in Minutes Book #12.

Item F: The Commissioner had the 2nd Reading and **approved** the amendment to Part 1 Special Acts, Article IV Judicial, Division 2 Magistrate, Section I-IV-23 Compensation regarding the part-time Magistrate combined days. The amendment is ordained and effective the first day of November, 2022.

Item G: Greg Hogan, Murray County's Sole Commissioner, presented to the public at today's meeting, an Intergovernmental Agreement, signed on October 26, 2022, between Murray County Government and Chatsworth Water Works Commission. The purpose of the agreement is for a sewer infrastructure expansion project. The project will extend the current sewer infrastructure, to the Crandall area of N. 411 Highway and will serve the area around the Appalachian Regional Port. Murray County will pay \$4,000,000.00 from SPLOST/ARPA Funds over the next 3 years to help fund this project.


Item H: Commissioner Hogan signed a letter of intent to join other counties within the Georgia Mountain Regional Commission to purchase digital products through 2023 GMRC Ortho-Imagery Project. The products provided to Murray County include 427 square miles of 6" Pixel Resolution 4-Band Color Infrared Digital OrthophOTOGRAPHY. The cost to Murray County is \$31,036.00 and will be paid from SPLOST Funds.

Item I: Tina Choate is appointed the position of County Clerk by Murray County Sole Commissioner, Greg Hogan. The appointment is **approved** and entered into the official Minutes of Murray County Government this first day of November, 2022. Signed documents are in Minutes Book #12.


The Sole Commissioner of Murray County Adjourned the meeting.
