# Summary

## Murray County Called Public Meeting July 25, 2023

The Sole Commissioner of Murray County, Greg Hogan, called the meeting to order promptly at 8:30a.m, July 5, 2023, in the Hearing Room of the Murray County Annex. In attendance were Greg Hogan, Sole Commissioner, Tommy Parker, County Manager, Billy Cantrell, City of Eton Mayor, K.W. Gong, City of Chatsworth Mayor, Terry Crump, City of Chatsworth Board Member, Larry Sampson, and Tina Davis, County Clerk.

The purpose of today's meeting is to publicly discuss the 2025-2023 SPLOST Distribution, Project List(s), and cost estimates.

The distribution of the FY 2025-2030 SPLOST would be distributed as follows:

- Murray County is to receive 87.5%
- City of Chatsworth is to receive 10.5%
- City of Eton is to receive 2%

The County will collect the SPLOST Tax and disburse monthly to the City of Chatsworth and the City of Eton.
